National Catholic Youth Conference November 16-18, 2017 Frequently Asked Questions

1 Where is the Conference?

Answer: The conference itself will take place in two main locations: Lucas Oil Stadium for mega sessions and the Indianapolis Convention Center for breakout workshops.

2. Where will we stay and how will we be traveling?

Answer: We will be staying with and traveling with people from the Archdiocese of Louisville. Our hotels will be off of the Southport Rd. exit on I-65 in Indiana and we will be traveling via coach buses the entire trip. Boys will be in rooms with other boys and girls in rooms with other girls. Should someone be found in a room of the opposite gender, they will be sent home immediately. No exceptions. We will have the specific hotel we will be in as the trip approaches and we are assigned by the Archdiocese.

3. Why are there only ten youth spots and two adult spots available?

Answer: The Archdiocese of Louisville allots us these spaces. They are available on a first come, first serve basis. Any additional participants will be placed on a waiting list.

4. How much is this going to cost me?

Answer: Overall, the trip will cost each person \$275 which includes a \$50 deposit due at the time of signing up for the trip. This is a huge reduction from the Archdiocesan price of \$480 a person due to grant money and the parish helping out with each person. You may choose to pay this outright or you may want to fundraise for the trip. Should you not be able to go for some reason, you are still responsible for your trip fees.

5. What will be the fundraising opportunities for this year?

Answer: We will meet together as a group at the end of the sign up period to determine fundraisers and dates. These will include our monthly pancake breakfasts that take place throughout the year.

6. What are the requirements that I need to meet to go to NCYC?

Answer: You must be a high school student in the fall of 2017 to attend NCYC and have attended at least one overnight retreat or mission trip with the youth ministry program prior to attending NCYC and be in good academic standing at school.

8. How much school will I miss?

Answer: You will be missing school on November 16th and 17th for NCYC. Each person is responsible for gaining permission from their school to go on the trip. Fraz will have letters for you to give to the principal but it is YOUR RESPONSIBILITY to find out about make up work and other school responsibilities. Should you not be in good standing at school before we leave for the trip, you will not be able to go to NCYC.

Nature of the Conference Event: I understand that the nature of this private Conference event sponsored by NFCYM and its member Roman Catholic Dioceses is: it will be held at the Indiana Convention Center and Lucas Oil Stadium ("Facilities"), in Indianapolis, Indiana, from November 19 to 21, 2015, some 25,000 youth and adults will attend over three days, and as a condition of using the Facilities, the Facilities require the Conference to retain security and medical personnel whose actions are beyond NFCYM's control. The Conference will be in session from noon-10:30 PM on day one and 7:30 AM-10:30 PM on days two and three, excluding breaks for meals and/or recreational activities.

Nature of Risks: I understand that voluntarily traveling to and attending a Conference of this nature may involve certain risks beyond the reasonable control of NFCYM, its officers, directors, volunteers, and agents in connection with the Conference ("NFCYM et al.") and the Diocese and all parishes within it, and their respective officers, directors, volunteers and agents, and chaperons or representatives associated with the Conference ("Diocese et al."), including but not limited to accidents, emergencies, exposure to reckless conduct of other persons, and/or negligence of security and medical personnel, and that NFCYM et al. and the Diocese et al. disclaim any and all responsibility for any such risks. I understand that my child will sometimes be at the Facilities, and at other times may be at other places such as hotels or on tourist excursions in or about Indianapolis. If during any break in the Conference there may be an opportunity to participate in recreational or other activities away from the Facilities, participants do so at their own risk and subject to all terms and conditions set by any recreational or other provider.

General Release & Waiver of Liability/Covenant Not to Sue & Hold Harmless: By signing this Agreement, I agree and acknowledge that I may be giving up important legal rights and remedies available to myself, my family, my heirs, successors, and assigns. This is a "General Release" which means that I am giving up and releasing important legal rights described below, and it is to be construed in the broadest possible manner.

For value received, I agree on behalf of myself, my child's other parent if known or living, my child named herein, and our heirs, successors, and assigns ("Our Behalf") that I assume all risks and waive any liability of any nature whatsoever against and agree to hold harmless NFCYM et al. and the Diocese et al. with respect to any and all actions, claims or demands that may be made or brought on Our Behalf against NFCYM et al. and/or the Diocese et al. arising out of or in connection with my child's travel to or attendance at the Conference, or any other activity my child may engage in while in the Indianapolis area. In addition, and not by way of limitation, I further agree to abide by any terms and conditions imposed by name badges or credentials, e.g., permission to photograph.

A "Covenant Not to Sue" is a legal term that means a person promises not to file a lawsuit. It is different from the General Release of claims above. Besides waiving and releasing the claims covered above, I covenant on Our Behalf not to sue and promise never to file or prosecute any legal claim of any kind against NFCYM et al. and the Diocese et al. in any federal, state or municipal court, asserting any claims that are released by this Agreement. I am also waiving on Our Behalf any right to monetary recovery.

Further, for value received, for any injury to third parties that may arise because of my child's actions or omissions, I agree on Our Behalf to hold harmless and defend NFCYM et al. and the Diocese et al. with respect to any and all actions, claims, expenses, or demands arising therefrom that may be made or brought against NFCYM et al. and/or the Diocese et al., including but not limited to reasonable attorneys' fees and expenses arising in connection therewith.

Medical Permissions (Limited): As a condition attending the Conference at the Facilities, on Our Behalf, I grant permission in the event of an emergency or accident for emergency medical care to be administered to my child within the Facilities and/or during or after transportation to a hospital or doctor for emergency medical care. I understand that in Indiana a person may claim Good Samaritan defenses for providing in good faith gratuitous emergency care at the scene of any emergency or accident. I further understand that it is not the responsibility of NFCYM et al. to attempt to reach my child's emergency contacts and that I remain responsible for my child's medical expenses. In the event it comes to the attention of the medical personnel or the Diocese et al. that my child by medical personnel or the Diocese et al.
